1. Correction to reference in U2.3  
The reference is updated to RRS 43.1(a) instead of RRS 64.1(a).

## Change 2 – SNoR v1.21

29<sup>th</sup> April 2021

2. Changes to paragraph 4; Event Details
  - a. BKL Cardiff Bay
    - i. The event will now take place on 4<sup>th</sup> & 5<sup>th</sup> September instead of 22<sup>nd</sup> & 23<sup>rd</sup> May.
  - b. BKL Youth Championship (Island SC)
    - i. The Island Sailing Club (Cowes) is confirmed as the new venue for the BKL Youth Championship on 10<sup>th</sup> & 11<sup>th</sup> July.
  - c. 4<sup>th</sup> & 5<sup>th</sup> September
    - i. BKL Cardiff Bay has been rescheduled to this date.
    - ii. BKL Poole YC has been cancelled.
    - iii. Poole YC will become hosts for the BKL Series Final – see below.
  - d. BKL Series Final
    - i. Confirmation of Poole YC as the host for the BKL Series Final. There is no change to the date or entry fee for this event.

4. Change to 10.4, Series Final winners' trophy.

5. Changes to paragraph 4; Event Details
  - a. Entry Deadline for BKL Cardiff Bay changed from 3<sup>rd</sup> May to 10<sup>th</sup> May to bring in line with other events
  - b. **Cancellation of the BKL Youth Championships (24<sup>th</sup> & 25<sup>th</sup> July 2021; RTYC)**  
*The Organising Authorities are actively working to reschedule this event which is likely to be on a different date and at an alternative venue. SNoR 5.5 remains in place to allow for this.*
  - c. Change of Venue for the Series Final; from **RTYC at Queen Mary SC** to **TBC**  
*There will be change of venue for the Series Final. This will be confirmed with a further change as soon as possible. The Organising Authorities do not plan to change the date for this event.*
